Commercial and industrial fees base upon current commercial/industrial fee schedule.
The above fees are base fees. If inspector has to do additional inspections or re-inspections, charges of \$60.00 per inspection will be added.

Electrical work shall not be started until the application for permit has been filed. If work has been started prior to obtaining proper permits, an additional fee of \$100.00 will be added to cost of permit. All installations shall be in conformance with the electrical code. No work shall be concealed until it has been inspected and approved.

When ready for an inspection, call John McAuliffe (1-269-967-5964) between the hours of 8:00AM and 4:00PM Monday thru Friday. Provide a minimum of 24 hour notice for inspection. The inspector will schedule the inspection as soon as possible. In the case of notification on Friday, the inspector will schedule for early the following week. You must provide the name, address, and permit reference number with request for inspection.

EXPIRATION OF PERMIT: A PERMIT REMAINS VALID SIX MONTHS FROM ISSUANCE, OR SIX MONTHS FROM LAST INSPECTION. A PERMIT WILL EXPIRE IF AUTHORIZED WORK IS NOT COMMENCED WITHIN SIX MONTHS OF PERMIT ISSUANCE, OR IF AUTHORIZED WORK IS SUSPENDED OR ABANDONED FOR A PERIOD OF SIX MONTHS FROM ISSUANCE OF PERMIT OR LAST INSPECTION. A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED, AND OR CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE, OR THE DATE OF THE PREVIOUS INSPECTION. CANCELLED PERMITS WILL NOT BE REFUNDED OR REINSTATED.

1. When the electrical system rating does not exceed 400 amps and the building is not over 3,500 square feet in area.			
2. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.			
PLANS MUST BE SUBMITTED BEFORE A PERMIT CAN BE ISSUED.			
V. APPLICANT SIGNATURE			
Section 23a of the state construction code act of 1972, 1972 PA 230, MCL 125; 1523A, prohibits a person from conspiring to circumvent the licensing requirements of this state relating to persons who are to perform work on a residential building or a residential structure. Violators of section 23a are subjected to civil fines.
